DELEGATIONS

Community Futures Alberni-Clayoquot

Reana Miller provided information on the proposed Adventure Sport Park project, an initiative to create an all ages multi-component skills development park for the adventure sports of skateboarding, BMX, and mountain biking in the Echo Park area. Council directed staff to prepare a report outlining potential opportunities for the City to support the project.

Alberni Clayoquot Health Network

Marcie DeWitt presented an annual overview of the Network, a community driven mechanism that helps to build partnerships and capacity; share concerns, ideas and resources and create innovative solutions that impact the social determinants of health and work towards sustainable healthy communities.
