## DELEGATIONS

#### **Comprehensive Youth Strategy**

Indigenous Policing Constable, Elizabeth O'Connor, Alberni Drugs and Alcohol Prevention Service Executive Director, Deb Hamilton and School District 70 Indigenous Contact, Dave Maher provided Council with a 5-year Comprehensive Youth Strategy.

Council supported the Engagement Strategy for the policy development phase of the OCP review and update prepared by FRANK Planning Collaborative.

## STAFF REPORTS

## **RCMP** Department

Sergeant Thompson on behalf of Inspector Eric Rochette presented policing activities undertaken during the months of October to December 2022, noting that overall, criminal offences are down by 8% compared to this same timeframe last year.

Council rescinded "Freedom of Information and Protection of Privacy Policy" (2005), and approved "City of Port Alberni Privacy Policy 3002-3".

Council received the report entitled "UNDRIP Update Report".

## BYLAWS

"Official Community Plan Amendment No. 37 Bylaw No. 5046", "Zoning Text Amendment No. T31 Bylaw No. 5047" and "Zoning Map Amendment No. 48 Bylaw No. 5048" were adopted. The bylaws will enable a high-density, multi-family in-fill development at 4738 Athol Street.

"Zoning Map Amendment No. 59 (3911 and 3909 Cedar Street – Hopkins), Bylaw No. 5072" was read a third time. The proposed bylaw, upon adoption, will enable a subdivision application (lot line adjustment) with the aim of building a new single detached dwelling at 3909 Cedar Street.

## NEW BUSINESS

City Street Lights - Request for Staff Report | Notice of Motion provided January 9, 2023 Council directed staff to prepare a report for Council's consideration regarding City street lights including the process for reporting repairs and outages.

#### Strategic Priorities - Request for Staff Report | Notice of Motion provided January 9, 2023

Council directed staff to prepare a report for Council listing all issues requiring Council's consideration with a recommendation as to each one's priority.

#### Routine Release of In-Camera Information Policy | Notice of Motion provided January 9, 2023

Council directed staff to bring forward a report on Procedure Bylaw changes that would increase transparency with the routine release of in-camera agendas, resolutions, and related materials.

## Development Application | 4210 Cedarwood Street

Council authorized the issuance of Development Variance Permit No. 115 for 4210 Cedarwood Street granting variances to building height and required amount of parking spaces, bringing the existing property into compliance and facilitating the issuance of Development Permit No. 22-01 enabling construction of a 35-unit affordable housing development.

### Development Application | 3900 Burde Street

Council authorized the issuance of Development Permit No. 22-05 to construct a series of duplex, four-plex and six-plex buildings totalling 76 residential dwelling units.

### Eagles Hall | Cold Weather Shelter

Council authorized temporary deferment of the Zoning Bylaw at Eagles Hall to enable Salvation Army to operate a temporary cold weather shelter until March 31, 2023.
